

- Buenos días, good morning everyone.
  
- I would like to thank Mr. John Anderson, Ms. Lynn Costa, and the APEC SME Business Ethics for SMEs Forum for inviting me today. And thank you to Peru for hosting one of a series of very successful meetings which Peru is hosting as 2016 APEC Chair.

The Government of Canada therefore works with interlocutors at international, bilateral and organizational levels on a range of activities which strengthen the environment affecting business abroad in a way that is conducive to advancing CSR performance and benefits on the ground.
  
- We work with the Canadian business community, civil society organizations, foreign governments, international organizations and communities, as well as other stakeholders to foster and promote responsible business practices, and thus support sustainable economic growth and shared value.

- I think APEC SMEs are uniquely positioned to be drivers of corporate social responsibility promotion efforts given their flexibility, adaptability, innovativeness and drive.
  
- All this being said, I would like to thank the United States and the leaders of this special initiative for all their efforts to develop a capacity-building program to strengthen ethical business practices among SMEs over the past six years.
  
- More particularly today however, I would like to thank Mr. Williams and Ms. Nikidis for not only their contributions toward APEC's efforts in this area, but also for representing Canada so well on the international stage.
  
- Their sustained leadership on the drafting of the Mexico City Principles for the Biopharmaceutical Sector in 2011 and their work as Co-Chair of the APEC Biopharmaceutical Working Group on Ethics since then, and all their mentoring efforts have been outstanding and truly worthy of recognition.
